However, it's a well on the other side of the road that I am after information on.

I have attached above a copy of resource consent U090668 to install a bore on Lot 2 DP 378544 and a copy of your well log 1314 .

You will see that the coordinates on the log are very close to the consent except that the northing on the consent is 5969541 and the log is 5968533.

I didn't pick it up at the time we received the log from you and rightly or wrongly had assumed that this well log related to the well 10181 consented to under U090668.

Can you tell me if the coordinates on the well log are correct or if not what the correct coordinates should be.

To help, the graphic below identifies the site where U090668 authorised the construction of a well.

The graphic below shows the authorised site (in pale blue) at the top of the image and the locations of the coordinates (in red) at the bottom of the image.
